
Legionella Testing Now Available

Legionella Pneumophila is a bacteria that can lead to infections known as Legionellosis. The severity varies from mild febrile illness (Pontiac Fever) to a potentially fatal form of pneumonia called Legionnaires' Disease.

Legionnaires' disease is a legitimate public health concern as its fatality rate during an outbreak ranges from 5% to 30% in those who contract the disease. The immediate consequences for the building owner or manager faced with liability claims and negative publicity can be devastating and extremely costly.

Many experts agree that proactively managing the risk of Legionella bacteria in cooling towers and water systems is more cost effective than responding to an outbreak retroactively.

Where is Legionella Found?

Any commercial facility where water is used or stored (for example sinks, taps, showers, hot tubs, water tanks, cooling towers, decorative fountains, toilets, hot and cold water supply) and

where there is a means of creating and transmitting water droplets which may be inhaled, thereby causing a reasonably foreseeable risk of exposure to legionella bacteria.



This includes care homes, hotels, guest houses, spas/leisure

centers, dental and surgical centers, health care premises, schools, universities, colleges and manufacturing/distribution sites.

Legionella testing is required to ensure compliance with the 42 Code of Federal Regulations (42CFR). In addition, effective June 2, 2017, nursing and retirement facilities must conduct a facility risk assessment to identify potential locations for Legionella bacteria.
